

REJECTION OF UNLAWFUL VACCINE MANDATES

The COVID-19 vaccines are unsafe, to the point that their mandate should be considered the same as an order to consume poison; all of the options in the US are gene-therapy, either by mRNA or via a viral-vector, and as such are using an experimental and dangerous technology.



As laid out in the paper '[COVID-19 RNA Based Vaccines and the Risk of Prion Disease](#)' there are risks of prions, but it also clearly states:

Approving a vaccine, utilizing novel RNA technology without extensive testing is extremely dangerous. The vaccine could be a bioweapon and even more dangerous than the original infection.



The phase three trials are also not scheduled to complete until 2022 & 2023, so any government approval is premature and warrants a full corruption investigation, as well as lending evidence that the health and safety of our military is NOT being held in high regard.

Such reckless orders are *prima facie* illegal because they, themselves, rise to meet the criteria of [UCMJ Article 118](#) (murder) and/or [Article 119](#) (manslaughter); moreover, to condemn all service-members thus is nothing less than Treason as defined by the US Constitution, Art 3, Sec 3:

Treason against the United States, shall consist only in levying War against them, or in adhering to their Enemies, giving them Aid and Comfort.



THE TELEOLOGICAL REJECTION

The purpose of the military is to defend the nation from enemies, both foreign and domestic. This purpose is stymied by the adverse reactions: myocarditis; pulmonary-, neurological-, & autoimmune-damage, and possible death.

Given the reaction rates are certainly higher than being reported on, this poses a significant risk to the fulfilment of the purpose of the military.
